ORDINANCE GRANTING THE RECORDER'S REQUEST TO USE MONIES FROM THE RECORDER'S RECORDS PERPETUATION FUND TO SUPPLEMENT THE RECORDER'S 2025 BUDGET

By the affidavit contemplated by I.C. 36-2-7-10.2 (b), the County Recorder has requested the sum of \$30,000.00 from the County Council of the Recorder's Perpetuation Fund be used to supplement payment of the Replacement Employee Salary for the 2025 calendar year.

Pursuant to I.C. 36-2-7-10.2 (c), upon receiving the Recorder's Affidavit, the County Council may adopt an ordinance approving the Recorder's request.


The Recorder's affidavit is in proper form and content and the County Council wishes to grant the Recorder's request.


NOW, THEREFORE, IT IS ORDAINED AS FOLLOWS:



ADOPTED by the County Council of DeKalb County, Indiana this 27th day of August, 2024.



SWORN STATEMENT OF LETA HULLINGER, DEKALB COUNTY RECORDER

Comes now, Leta Hullinger, the duly elected Recorder of DeKalb County, Indiana, and submits her Sworn Statement to the DeKalb County Council pursuant to IC 36-2-7-10.2(b) in order that the DeKalb County Recorder may pay for a portion of the expenses of the DeKalb County Recorder's Office for calendar year 2025 from the Recorder's Records Perpetuation Fund established under IC 36-2-7-10(d). Under penalties for perjury and under oath, Leta Hullinger, DeKalb County Recorder, states as follows:

- (1) The current revenue to the fund is sufficient to fulfill the statutory purpose of the fund;
- (2) The technology of the County Recorder's Office is presently updated and at a level to sufficiently meet the statutory purposes of the fund and the County Recorder's Office;
- (3) The fund has a sufficient reserve, consistent with the recorder's plan, to capitalize the next technology or other records management upgrade necessary to fulfill the statutory purpose of the fund and the County Recorder's office; and
- (4) The County Recorder specifically requests a portion of the fund be used to pay the expenses of the County Recorder's Office, except for salaries and part time extra help, which are paid out of the County General, for the following calendar year.
- (5) The County Recorder specifically requests a buffer for unidentified expenses and recreating years of documents not retrievable.
