D. Approval of the 2026 Adult DCCC and Probation MH Grant Application and Budget. -VOTE.
Documents attached for discussion. Grant applications are due April 11th.

E. Director's Updates:

- a. DCCC staff are completing training in the ODARA (Ontario Domestic Assault Risk Assessment) to supplement the risk scores received from the IRAS in intimate partner violence cases. This will assist with case planning, supervision level, and referral to service decisions, as well as providing enhanced information to the Courts for pretrial release decisions.
- b. DCCC hosted the regional technical assistance training for Univ. of Cincinnati and IDOC's Community Supervision Assessment on March 18th & 19th. DCCC created goals in 5 prescribed areas:
 - i. Leadership, Management, and Support- goal to create a policy for piloting new projects or policies.
 - ii. Staff Characteristics- goal to begin reviewing specific participant cases during phasing review meetings.
 - iii. Offender Assessment- research and identify a level of intelligence and/or low motivation assessment to incorporate into case management.
 - iv. Evidence-based practices- goal to create post-supervision transition plans for participants.
 - v. Quality Assurance- goal to begin external CQI with our treatment partners.
